Up to 100% of the CCB can be used to qualify.

#### **Parental Leave**

Up to 100% of income from their primary occupation can be applied if the expected return date is within 18 months of the last day worked.

- GDS/TDS: 41%/43%
- Property: Marketable Ottawa property
